<u>Director, Co-founder, Gender Justice Clinic (GJC), University of Florida, Levin College of Law, Gainesville, FL, Opening Fall Semester, 2022</u>

The Gender Justice Clinic (GJC) is a multi-disciplinary clinical program serving low-income Floridians who face violence, discrimination or other oppression based on their actual or perceived sex, sexual orientation, gender identity, or gender expression. Clients include those who identify as lesbian, gay, bisexual, transgender, non-binary, questioning, intersex, and gender non-conforming. GJC assists clients with name and gender marker changes for adults and guardians of minor children with needing these identity-confirming procedures. Law students practice skills learned in the clinical classroom while representing clients (interviewing and counseling, filing and responding to pleadings, engaging in discovery, taking and defending depositions, negotiating with opposing counsel, litigating in courtroom,

etc.). GJC law students also research and write "white" papers on a variety of issues affecting LGBTQ+ person not only in Florida, but throughout the United States. Students also closely watch State and Federal litigation affecting the rights of the LGTBQ+ community.

<u>Director, Co-founder, Intimate Partner Violence Assistance Clinic (IPVAC), University of Florida, Levin</u> College of Law, Gainesville, FL January 2010 – present

IPVAC is a" first of its kind" multidisciplinary clinical program within the law school that provides legal counseling and representation (State Circuit Court), mental health counseling and case management services to indigent survivors of domestic, dating, sexual and stalking violence. This clinical experience provides intensive interdisciplinary skills training to UF law students. Law students practice skills learned in the clinical classroom while representing survivors/clients (interviewing and counseling, filing and responding to pleadings, engaging in discovery, taking and defending depositions, negotiating with opposing counsel, litigating in courtroom, etc.). Students also work with a variety of local and state organizations/agencies such as the Office of the State Attorney, Department of Children and Families, law enforcement, Child Protection Team, Child Advocacy Center, Guardian ad Litem, certified domestic violence centers, and Partnership for Strong Families, Inc. These students are instructed/mentored by the IPVAC staff which consists of the director and a licensed clinical social worker.

Beginning Fall of 2018, IPVAC added an Immigration Clinic, serving indigent survivors of immigration with relief such as U-Visa's, VAWA Self-Petitions, Adjustment of Status Applications, and Removal of Conditions requests. This second clinic was funded by the Florida Bar Foundation as a joint effort between UFLaw and FSULaw. Joint classes were held weekly via Zoom technology

Co-Founder, Peace4Gainesville (P4G), A Trauma Responsive Community Initiative, 2014-present. In partnership with UF College of Law's Center for Children and Families, P4G designed and coordinated the largest "toxic" trauma conference ever held in North Florida in 2014. In attendance were over 300 child professionals, law enforcement, mental health professionals, UF academic faculty, health care providers, criminal and civil justice system personnel and local government. Speakers included two internationally renowned psycho-neurobiologists and experts from throughout the state focused on the effects of Adverse Childhood Experiences on children. Also, partnered with the University of Buffalo School of Social Work to host a second conference for leaders of child-involved agencies regarding trauma informed organizations. P4G meets regularly to discuss community initiatives around childhood trauma and resiliency building. P4G also provides trauma/resiliency trainings throughout the State. Developed protocols for partnerships with new Domestic Violence Task Force created by local law enforcement with grant of federal funds. Co-prosecuted largest felony child abuse case in history of the state, involving 25 adopted child victims with varying levels of disabilities.

Child Welfare Legal Services, August 1996 – April 2002: Served as one of eight Assistant State Attorneys who designed and implemented a pilot program representing the Department of Children and Families (DCF) in all civil phases of dependency proceedings involving child victims of abuse, abandonment and/or neglect across the Eighth and Third Judicial Circuits in Florida. Handled largest caseload in Alachua County, but also participated in trials and trained attorneys in 11 other counties in North Central Florida. Participated in the development of a three year federal grant geared to reduce the length of time to permanency in complex cases. Helped implement both a Dependency Drug Court and a Dependency Mediation Program. Litigated over 50 adjudicatory hearings, including the largest termination of parental rights trial in the state, involving 18 child victims.
