

# Professional Responsibility Spring Semester 2025 Law 6750-12806 3 Credits

# **Professor William Hamilton**



This course will give you an overview of the law governing lawyers and explore the ethical problems you will encounter in law practice. The primary focus of the course will be ethical problem-solving. The course aims to provide the tools, resources, and perspective necessary to address complicated ethical and professional issues you will face in practice. The focus of the course will be the ABA Model Rules and the Florida Bar Professional Responsibility Rules that materially diverge or supplement the ABA Rules. The course is designed in part to assist students'

preparation for the Multistate Professional Responsibility Examination (MPRE) and the ethics component of the Florida Bar Examination.

# **Student Learning Outcomes:**

By the end of this course, students will be able to:

- Read and understand the rules, commentary, statutes, and judicial opinions governing the professional conduct of lawyers.
- Understand the ethical, moral, and policy concerns underlying the law regulating lawyers.
- Identify professional responsibility issues in given fact patterns and work through their solutions using the relevant legal rules.

# **Required Text**

The required text for this course is Jefferson, Pearce, et al., PROFESSIONAL RESPONSIBILITY: A CONTEMPORARY APPROACH –INTERACTIVE VERSION (5<sup>th</sup> edition 2023). 

# **Teaching Philosophy and Instructional Methods:**

The course emphasis is on solving practical problems. We will have many class discussions, practical exercises, and practice multiple choice questions.

You may wish to review the literature on experiential learning. Peter C. Brown's Make It Stick: The Science of Successful Learning largely captures my philosophy.



#### This Course Is Graded on a Curve

This course is graded on a curve. The Registrar provides me with a curved grade range; the class grade average must be within that range.

Course points may be earned as follows:

1. Class Attendance and Participation: 50 points (2 points per class).

Class attendance and participation are expected. Each class is worth 2 points.

Class participation requires:

- (1) Asking and answering questions that illuminate the issues,
- (2) Asking and answering questions that enrich the class dialogue and advance the class's understanding of the issues,
- (3) Participating in the class dialogue and discussions,

- (4) Participation in team debates and mock exercises,
- (5) Engaging in-class activities, exercises, and projects.
- (6) Demonstrating class preparation.

Classes will contain numerous individual and group exercises and problems. The classes will be recorded, and access will be provided to all students enrolled in the class. You may not take, circulate, or post photos or videos of classroom discussions, whether they are in-person, hybrid, or completely online. Students failing to follow this rule will be referred to the College of Law Honor Code Council and the university's Office of Student Conduct and Conflict Resolution.

You may have legitimate and compelling personal and professional requirements that may cause a class absence. If you will not attend a class for personal or professional reasons, please notify me in advance as a professional courtesy. I will provide attendance points for students who notify me before an absence. When you have not provided me with advanced notice, attendance points will be provided for missed classes only based on compelling circumstances.

Please let me know how you would like to be addressed in class if your UF-rostered name does not reflect your name and pronouns.

## 2. Mid-Term Examination (150 points)

There will be a 1:25 hour, 25-question, multiple choice in-class closed book mid-term examination. The final examination will require you to analyze factual scenarios, identify the appropriate legal rules, apply the rules, and reach a conclusion. There will be numerous in-class and take-home practice questions in the weeks before the mid-term.

#### 3. Final examination (300 points)

There will be a 2-hour, 50-question, multiple-choice, on-campus closed book proctored final examination. The final examination will require you to analyze factual scenarios, identify the appropriate legal rules, apply the rules, and reach a conclusion. There will be numerous in-class and take-home practice questions in the weeks before the mid-term.

#### **Class Cancellations**

Occasionally, I may have to reschedule a class due to professional demands. If this happens, I may record video lectures for the class to watch or conduct the class remotely via Zoom. Information about such changes will be sent on Canvas and by email.

# Class Preparation, Participation, and Attendance:

Students are expected to attend class, to be prepared, and to participate in class discussions. It is your responsibility to complete the daily attendance assignment on Zoom. By completely the assignment you affirm that you are physically present in class during that class period. It will be considered a violation of the course rules and the Honor Code to falsely indicate that you were present in class, or to assist a classmate in such misrepresentation.

Pursuant to ABA guidelines, students who have four (4) or more unexcused absences will be barred from taking the final exam and will automatically fail this course. Two or three unexcused absences may result in a reduction of your grade as described above, in the section describing grade adjustments for course participation. Absences necessitated by religious holidays are exempted by this policy, so long as you give me advance notice of your absence. More generally, if you are concerned that you may come close to the limit on absences, it is a good idea to keep me informed as to what's going on, so that we can explore whether some accommodation is possible.

# **Taking Notes Should in Class:**

I recommended that you do not take word-for-word literal notes. This is not a court reporting class! Instead, think about what is happening in class and record the key ideas. Handwriting your notes is better for you than typing notes. Check out this article: <a href="Note-Taking: Writing vs. Typing Notes">Note-Taking: Writing vs. Typing Notes</a>. Beyond that, it is a good legal skill. You will need to learn to take good witness interview notes, deposition notes, and trial notes. A computer will not always be available or good to use.

# **Recording Devices and Cell Phones:**

Cellular telephones should not be used during class and ringers should be silenced.

Students are allowed to record video or audio of class lectures. However, the purposes for which these recordings may be used are strictly controlled. The only allowable purposes are (1) for personal educational use, (2) in connection with a complaint to the university, or (3) as evidence in, or in preparation for, a criminal or civil proceeding. All other purposes are prohibited. Specifically, students may not publish recorded lectures without the written consent of the instructor.

A "class lecture" is an educational presentation intended to inform or teach enrolled students about a particular subject, including any instructor-led discussions that form part of the presentation, and delivered by any instructor hired or appointed by the University, or by a guest instructor, as part of a University of Florida course. A class lecture does not include lab sessions, student presentations, clinical presentations such as patient history, academic exercises involving solely student participation, assessments (quizzes, tests, exams), field trips, private conversations between students in the class or between a student and the faculty or lecturer during a class session. Publication without permission of the instructor is prohibited. To "publish" means to share, transmit, circulate, distribute, or provide access to a recording, regardless of format or medium, to another person (or persons), including but not limited to another student within the same class section. Additionally, a recording, or transcript of a recording, is considered published if it is posted on or uploaded to, in whole or in part, any media platform, including but not limited to social media, book, magazine, newspaper, leaflet, or third-party note/tutoring services. A student who publishes a recording without written consent may be subject to a civil cause of action instituted by a person injured by the publication and/or discipline under UF Regulation 4.040 Student Honor Code and Student Conduct Code.

Workload/class preparation and the 2:1 out-of-class/in-class requirement (ABA Standard 310):

- 1. Students should expect to spend an average of approximately two hours preparing for every hour of class. Reading assignments are posted on the "Modules" link on the Canvas site (located on the left side of the site).
- 2. It is anticipated that you will spend approximately 2 hours out of class reading and/or preparing for in-class assignments for every 1 hour in class.

3. ABA Standard 310 requires that students devote 120 minutes to out-of-class preparation for every "classroom hour" of in-class instruction. (Course) Each week has 3 "classroom hours" of in-class instruction, requiring at least 6 hours of preparation outside of class.
