- The Objective of this course is for you to write a substantial paper regarding a tax topic of your choice, as approved by me.

 - To write an acceptable paper.
 - Whatever the subject matter of your topic.

PREPARATION:

• Students should expect to spend, on average, approximately two hours preparing for every hour of class, according to ABA and University guidelines. ABA Standard 310 requires that students devote 120 minutes to out-of-class preparation for every "classroom hour" of in-class instruction. Essentially, you should spend two hours for each credit hour (2) times 13 (the allotted number of weeks) for a total of 52 hours.

Everyone should know what others are working on, as you can provide substantial help to each other. Initially, I will lead a discussion on any topic brought up.
- I will make my Introduction to Tax School data base available to you. We will go through this during the semester (if we are not discussing your topics). I will help you learn what I think you should know before the semester starts (of course, few students do).
