COURSE DESCRIPTION

Florida Criminal Procedure is a three-credit graded course.

This course covers the procedural law in Florida criminal practice. The nature, purpose, and application of various rules will be discussed. In addition to a careful study of the rules, students will read assigned cases illustrating the function(s) of major provisions. The course is designed and intended to prepare students for success on the bar exam and in the practice of criminal law. Three quizzes will be given throughout the semester and the final will be composed of three short-answer essay questions.

COURSE GOALS AND OBJECTIVES

Students will become familiar with and have a working knowledge of the Florida Rules of Criminal Procedure. Students will be able to recognize procedural issues in cases and understand how the rules (should) operate or apply on behalf of the prosecution or an accused individual. Students will learn to recognize principles of fairness in process and how rules should work to further (and not frustrate) fairness. Students will also recognize how the Florida Rules of Criminal Procedure (should) promote and extend federal constitutional protections and will be able to recognize, where applicable, the federal constitutional roots of Florida's criminal procedural rules.

LEARNING OUTCOMES

Students will be prepared and confident in their knowledge of Florida's criminal rules and procedures, both when they take the bar and in practice. Students will have entry

level knowledge of rules used in the practice of criminal law and a basic understanding of how the rules operate at critical stages of criminal cases.

COURSE MATERIALS

- The Florida Rules of Criminal Procedure
- The constitutions of the State of Florida and the United States
- The 2025 Florida Statutes
- Assigned decisions, primarily from the Florida Supreme Court and Florida District Courts of Appeal, and occasionally from the U.S. Supreme Court
- Hypothetical fact patterns

Please be sure to register for the Canvas course and have any required materials with you in print or in easily accessible electronic form in class. You are responsible for checking your Canvas page and the email connected to the page on a regular basis for any class announcements or adjustments.

PREPARATION

ABA Standard 310 requires that students devote 2 hours to out-of-class preparation for every "classroom hour" of instruction. Florida Criminal Procedure has 3 hours of inclass instruction each week, requiring at least 6 hours of preparation outside of class each week.

CLASS ATTENDANCE POLICY

Students are not allowed any unexcused absences during the semester and should try to limit excused absences to three. RECORDINGS OF CLASS

Students may record video or audio of class lectures. However, the purposes for which these recordings may be used are strictly controlled. All other purposes are prohibited.

Specifically, students may not publish recorded lectures without the written consent of the instructor. A "class lecture" is an educational presentation intended to inform or teach enrolled students about a particular subject, including any instructor-led discussions that form part of the presentation, and delivered by any instructor hired or appointed by the University, or by a guest instructor, as part of a University of Florida course. A class lecture does not include academic exercises involving solely student

participation, assessments (quizzes, tests, exams), or private conversations between students in the class or between a student and the faculty or guest lecturer during a class session.

Publication without permission of the instructor is prohibited. To "publish" means to share, transmit, circulate, distribute, or provide access to a recording, regardless of format or medium, to another person (or persons), including but not limited to another student within the same class section. Additionally, a recording, or transcript of a recording, is considered published if it is posted on or uploaded to, in whole or in part, any media platform, including but not limited to social media, book, magazine, newspaper, leaflet, or third-party note/tutoring services. A student who publishes a recording without written consent may be subject to a civil cause of action instituted by a person injured by the publication and/or discipline under UF Regulation 4.040 Student Honor and Student Conduct Code.

As each individual class is relatively short, students are encouraged to utilize office hours or appointments as necessary to clarify complex topics and ensure readiness for quizzes/exams.

It is recommended to access the Florida Rules of Criminal Procedure through Westlaw or LexisNexis for the most up-to-date version. In addition to Westlaw/LexisNexis, the Florida Constitution may be accessed here; the Florida Statutes here; and the U.S. Constitution here.
