

Law 7911-Federal Tax Research Course Syllabus

Course Description: The goal of this course is to provide support, instruction and evaluation aimed at writing a robust (20-25 pages) tax research paper on a carefully selected federal tax research topic.

Course Objectives

- Students will effectively research and select compelling topics that warrant further research and analysis.
- Students will focus on how to communicate an analysis of various sources of tax law in persuasive, professional writing.
- Students will effectively and ethically incorporate AI into their research, drafting, and revision process.
- Students will scout and find potential audiences and places of publication for their work.
- Students will have a thorough understanding of different ways to organize and present their research.
- Students will understand how to collaborate, give helpful feedback, and support peers during their tax research.
- Students will learn to effectively use and incorporate feedback from peers and professors to revise and improve drafts.

Course Schedule

Introduction to Tax Research and Tax Law- Goals, Deadlines, Objectives- January 23rd

This class will be an introduction to tax law research, classmates, and the professor. We will go over class goals and expectations. Class will also include a brief overview of different areas of tax law and the different tax types.

Unit 1: Research Topic Selection and Research Question Formation-January 30th and February 6th

During this unit we will discuss tips and methods to identify and select a worthy research topic. Class will also collaborate to create a bank of research topics from which students can select a topic. Class will also use preliminary research to turn a general research topic into a specific research question.

Unit 2: Gathering Sources for the Topic & Ethical AI Usage -February 13th and February 20th

During this unit we will go over how to find and evaluate both primary and secondary sources for our research

topic/question. Also, we will discuss how to weigh the credibility of these sources. We will also discuss how to incorporate AI into our research and outline process.

Unit 3: Structuring, Organizing, and Outlining a Legal Research Paper- March 6th and March 13th

During this unit we will discuss how to structure, organize, and outline our papers to fit our potential audience. We will also begin first drafts based on professor and peer feedback on outlines.

Unit 4: Choosing your Audience- March 27th

During this unit we will take some time to consider places our research paper may appear and structure our writing style and topic coverage to fit our potential audience.

Final Class-Peer Review of Drafts and Outlines- April 3rd

During this class we will review and give feedback on outlines and drafts in preparation of the final paper submission.

Classroom Preparation

It is anticipated that you will spend approximately 2 hours out of class reading and/or preparing for in class assignments for every 1 hour in class. ABA Standard 310 requires that students devote 120 minutes to out-of-class preparation for every "classroom hour" of in-class instruction. Federal Tax Research has 2 "classroom hours" of in-class instruction each week, requiring at least 4 hours of preparation outside of class.

Quality papers are expected to compile and use research to make thorough and coherent conclusions and arguments. Also, a portion of the grade will be determined based on active and voluntary participation that is of consistently high quality in class discussion.
